Directions to Shamona Creek Park

(1101 Dowlin Forge Rd. Downingtown, PA 19335)

From Business Route 30 turn onto Route 113 North OR From Route 30 bypass, exit at Route 113 North (going towards Lionville). Turn left onto Peck Rd. (There is a Lukoil Gas Station, KinderCare and a Dunkin Donuts/Baskin Robbins at this intersection). Stay on Peck Rd. going past Uwchlan Hills Elementary School on your left. Follow Peck Rd. until it ends at Dowlin Forge Rd. Turn left onto Dowlin Forge Rd.. Park

entrance will be on the left about $\frac{3}{4}$ of a mile (look for wooden park sign on the left). Take driveway past the walking trail and the softball field and parking area are located at the top of the hill.

TIME LIMIT RULE PER GAME-TIME LIMIT**: We will allow no more than a maximum of 1 hour and 30 minutes per game. Time begins with the first pitch. A new inning will not begin after 1 hour and 30 minutes from the start of the game. The only time a game will be permitted to go longer is if a game is still tied after 1 hour and 30 minutes-it will be continued until a winner is determined.
